01. The class/section/subject-wise number of students mentioned by you in the reference proposal in your college must be actually on the fold. 2. The hours specified for lectures, demonstrations, tutorials, project work, should be as per the rules prescribed by the UGC, the university and the government.

03. For demonstration, the number of students should be at least 15 and 20 in the batch for first year to third year science class in science branch.

04. The subject wise hours shown must actually be in the timetable. Assistant / Associate Professors whose work load is insufficient up to 18/20 hours with 12 hours or more hours should take up the reduced work load of junior / unaided / additional subject in the same class.

05. Appointments to the said post should be made through the committee constituted in accordance with the university constitution and through advertisement and in accordance with all related rules of the government.

06. The minimum number of students of the subject / faculty / batch should be as per the prevailing rules prescribed by the government from time to time.

07. It is imperative that the college has the Government order regarding all the relevant subjects/batch sanctioned and qualified batches available.

08. In the next academic year, due to decrease in the number of students or other reasons, the number of teacher posts will be reduced accordingly.

Government decision dt. 13/02/2000 and dt. As per 16/06/2000 the recruitment of open category candidates who have not passed the (NET/SET) examination and also without the Roster is prohibited. Such assignments will be calculated on hourly basis. A teacher on hourly basis should not be given more than 09 hours. The faculty / course / additional batch in your college is being sanctioned subject to the approval given by the government to start it on permanent non-subsidy basis. Hence due to the appointments on the said posts

The college/institution shall be fully responsible for the expenditure on salary and allowances.

Incremental new posts / vacancies should not be filled without the approval of this office (without no-objection certificate).

Due to the sanctioned structure as above, the increased posts are 100 and 50 points as per the list (Code-1984) / M.N.S. and should be filled in compliance with the government rules.

Before appointing a new post, as per the Maharashtra University Act 1994 and as per the orders issued by the government from time to time and as per the permission given to our college on permanent non-subsidy basis as per government order reference 8, the figure of non-teaching posts is being approved.

Backward Classes / Handicapped / Freedom Fighters / Women Reservation etc. as determined by Govt. Keeping in mind the reservation prescribed for the constituents, care should be taken to regularly fill up the reserved / reserved posts in that cadre and the backlog should also be completed regularly. In case of non-teaching staff, appointments should be made following the age limit, educational qualification etc. prescribed by the government.

The full responsibility of the salary of the non-teaching staff appointed by the institution/college will remain with the institution/college. Nor will any wage subsidy be provided by the Government for such employees.

In case of any legal dispute or financial liability arising in connection with the appointment, it will be the sole responsibility of the organization.
